According to Wisconsin Statutes, homes transferred after the January 1, 2010 certification date can qualify for the Lottery and Gaming Credit if the property was used by the previous owner as a primary residence on January 1, 2010. ## 2010 LOTTERY AND GAMING CREDIT APPLICATION

You may claim the lottery and gaming credit for 2010 taxes, payable in 2011, if, on January 1, 2010, you were the owner of the property and used the property as your primary residence. You can have only one primary residence. The credit cannot be claimed on business property, rental units, land, garages or other properties that are not your primary residence, or by a non-Wisconsin resident.

If the property qualified as your primary residence on January 1, 2010, please complete and submit this form to your County Treasurer's Office, so the Credit will appear on your 2010 property tax bill.
